DIVISION 1 - GENERAL REQUIREMENTS  
Section 01 22 00R - Unit Prices (REVISED)

PART 1 - GENERAL

1.01 DESCRIPTION

- A. Provide labor, materials, equipment, and incidentals required for the completion of work shown on the drawings and/or specified in this section.
- B. This section describes the unit prices which will govern additions to or reductions from the Contract relative to the described work. Each unit price shall reflect all costs incurred to complete an item in accordance with the Contract Documents. These prices shall include the Contractor's costs, overhead, profit, insurance, taxes and other incidental expenses to complete the item.
- C. The quoted unit cost will be used to adjust the specified allowance amount. Unused portions of the allowance will be credited back to the Owner at the quoted unit price. Quantities of work beyond the specified allowance amount will be paid to the Contractor using the quoted unit price cost.

1.02 DESCRIPTION OF UNIT PRICES

- A. Unit Price No. 1: Excavation - CA-6 Fill
  - 1. Include in this unit price, the cost per in-ground cubic yard complete in place, to provide additional excavation and removal of unsuitable and/or unstable soil and placement of CA-6 gravel fill complete in place, compacted to specified density, not included in the Base Bid as shown, specified, and/or required, including all trades and any related work.
  - 2. In addition to excavation required to meet grades and elevations, each Bidder shall include in the Base Bid, the cost to remove 250 in-ground cubic yards of unsuitable soil material and replace with CA-6 gravel fill compacted to specified density as shown, specified, and/or required, including all trades and any related work. This allowance is to be used for unforeseen poor soil which might be encountered above and beyond the excavation required to perform the work.
- B. Unit Price No. 2: Binder Course Replacement
  - 1. Include in this unit price, the cost per square feet complete in place, to saw cut and removal of existing damaged and/or deteriorated bituminous binder course (assume 3" thickness) after surface grinding operations down to existing stone base. Properly prepare existing stone base to receive pavement. Apply tack coat and provide 3" compacted thickness binder course to be flush with adjacent binder course surface to remain.
  - 2. Each Bidder shall include in the Base Bid an allowance of 3,000 square feet of binder course replacement as specified, and/or required, including all trades and any related work. Minimum size of binder course replacement shall be 500 square feet.

C. Unit Price No. 3: Crackfill of Binder Course

1. Include in this unit price, the cost per linear foot complete in place, to provide crackfill of existing binder course following surface pavement grinding operations as shown, specified, and/or required, including all trades and any related work.
2. Crackfill shall meet ASTM D6690: Type I , Hot pour, single component, rubberized modified asphalt, filler and sealing compound. Flexible, non-tracking without pick up from foot traffic, and resistant to scuffing from turning vehicle traffic. Provide proper formulation recommended by manufacturer for project area climate. Provide products meeting above criteria from one of the following manufacturers:
  - a. The Brewer Company
  - b. Right / Pointe Company
  - c. Crafcoc Inc.
  - d. W.R. Meadows, Inc.
3. Each Bidder shall include in the Base Bid an allowance of 1,000 linear feet of crackfill of existing binder course following surface pavement grinding operations as specified, and/or required, including all trades and any related work.
